ELECTION OF PARENT GOVERNOR

There is a vacancy for a Parent Governor on the Governing Body of Benjamin Britten School. I am writing to give you details of the arrangements for nominations and voting procedures. Attached to this letter is a Nomination Form on which three parents who have children at the school can jointly nominate another parent for election as a Parent Governor. Certain conditions apply:

- No parent may nominate more candidates than there are vacancies.
- It is necessary for a Parent Governor to have a child at the school at the time he/she is elected. (The child can be in any year group).
- Certain people are disqualified from being Governors and these are described on page 3 of this letter.
- School Governors are subject to "Disclosure and Barring" (formerly CRB) checks and cannot be appointed to office, even if elected, until such time as an enhanced DBS check has been undertaken (as described on the attached sheet) and a satisfactory Disclosure received.

There is space on the Nomination Form for a statement of not more than 50 words by the person nominated in which they can give such details as they wish about themselves and their views. This statement would then be included on the voting paper should there be more nominations than there are vacancies available.

The term of office is initially for four years. Therefore, a Parent Governor elected now will hold office until 2027 and, like other Governors, will be eligible for re-election. **Their child does not need to be at the school for the duration of the four year term but they must have a child at the school at the time he/she is elected.**

We would like all parents to play as full a part as possible in their children's education and, therefore, it is hoped that you will consider putting yourself up for nomination or supporting another parent's nomination and that you will use your vote if there is an election. This is an opportunity to support your child's school and play an active part in its future development. If you have any queries about the role of a Parent Governor please do not hesitate to contact me.

Please return Nomination Forms via email to office@benjaminbritten.school, marked for the attention of Miss A. Stanley. The advertisement will remain open until we have received an appropriate number of applications.

ELECTION OF PARENT GOVERNORS - DISQUALIFICATION FROM MEMBERSHIP

This is set out in schedule 4 of The School Governance (Constitution) (England) Regulations 2012 and statutory guidance on these regulations.

- 1 No person under 18 years of age shall be appointed/elected as a Governor.
- 2 A person may not serve as a Governor of more than two schools.
- 3 Parent Governors cannot be:
 - Elected members of the local authority (LA)
 - Paid to work at the school for more than 500 hours in a year

Criteria for all Governors

A person is disqualified from holding or from continuing to hold office as a governor of a school at any time when they:

- Are the subject of:
 - A bankruptcy restrictions order, or an interim bankruptcy restrictions order
 - A debt relief restrictions order, or an interim debt relief restrictions order
 - An undischarged sequestration
- Are disqualified from being a company director and/or a charity trustee
- Have been removed from office as an elected governor within the last 5 years
- Are included in the list of those unsuitable to work with children
- Are disqualified from working with children, barred from regulated activity and/or disqualified from registering for childminding or providing daycare
- Have been sentenced to 3 months or more in prison (without the option of a fine) in the 5 years before becoming a governor or since becoming a governor
- Have received a prison sentence of 2 and a half years or more in the 20 years before becoming a governor
- Have at any time received a prison sentence of 5 years or more
- Have been fined for causing a nuisance or disturbance on school premises during the 5 years prior to or since appointment or election as a governor
- Refuse a request by the clerk to make an application to the Disclosure and Barring Service (DBS)

Arrangements for Checking Criminal Convictions

The school has a duty to refer the details of persons newly appointed or elected as Governors of the school to the Disclosure and Barring Service (DBS).

Each new Governor will be required to complete an online DBS disclosure form. We will then complete and submit the form to the DBS for checking criminal records. Should the outcome of the check be unsatisfactory, no appointment will be made.
